Quick Start Guide

TERMS OF USE: Shielded Ethernet cable and earth grounding must be used as conditions of product warranty. TOUGHCable" is designed for outdoor installations. It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, and Dynamic Frequency Selection (DST) requirements.

## Hardware Overview



PoE In Gigabit 802.3af PoE port. Connect this port to an auto-sensing 802.3af PoE Switch. The switch will automatically activate PoE.

Connect this cable to a 24V passive PoE device. **Cable Gland** Seals around the Ethernet cable and protects the *PoE In* port from the elements.

PoE Out Gigabit 24V passive PoE cable.

**End Cap** Secures the *Cable Gland* and covers the *PoE In* port.

## Installation

1. Remove the *End Cap* by turning it counterclockwise.



2. Remove the *Cable Gland* from the *End Cap*.



3. Insert the Ethernet cable connected to an 802.3af switch through the *End Cap* as shown.



4. Wrap the *Cable Gland* around the Ethernet cable as shown.



Push the Cable Gland back into the End Cap and ensure that it is securely seated.



6. Connect the Ethernet cable to the *PoE In* port.



7. Attach the *End Cap* by turning it clockwise.



8. Connect the *PoE Out* cable to the 24V
