

AmpliFi Affiliate Program Details

(updated Dec, 2018)

1. The AmpliFi Affiliate Program is only available within the United States
2. Every affiliate partner must accept the [Terms and Conditions](#) to be eligible to participate in the program.
3. We will pay Amplifi affiliate partners commission fees described in Section 4 below in connection with “Qualifying Purchases” (defined below), subject to exclusions described below.
 - a. Qualifying Purchases occur when a customer clicks through a Special Link (Affiliate Link) provided by us on your (affiliate’s) websites or social channel to visit the AmpliFi Site (www.amplifi.com); and makes a purchase on the AmpliFi site during the same session or within the next 30 days.
 - b. If the customer has clicked multiple Special Links, the sale will be attributed to the affiliate partner that first created the lead.
 - c. If a product is returned, the commission fee attributed to the returned product will be deducted from future payments to that affiliate partner.
4. Commission Fees
 - a. The standard Commission Fee will range from 5% to 10% based on the affiliate partner’s tier. The affiliate partner can earn more by selling more and move up the tiers to earn a higher percentage commission. See the table below.
 - b. The commission fee is earned on the cart subtotal, excluding taxes and shipping fees. If a product is on sale, the commission fee is earned on the discounted price, not the full MSRP.
 - c. The commission fee will be paid on the 15th of the following month.
 - d. We will directly deposit the fees you earn into the bank account you designate once you have provided us with the name of your bank, the account number, the name of the primary account holder as it appears on the account, and other requested identifying information (such as the ABA, IBAN or BIC number, if applicable)
 - e. The minimum amount required before a disbursement is \$100.00. If the commission earned is below such threshold, the commission fee will accumulate until the amount reaches the \$100 threshold before any commission is paid.
 - f. If any excess payment has been made to you for any reason whatsoever, we reserve the right to adjust or offset the same against any subsequent fees payable to you.

Commission Structure Breakdown

| Tier # | Sales Range (revenue) | Commision Rate | Commision Range |
|---------------|------------------------------|-----------------------|------------------------|
| 1 | \$0 - \$30,000 | 5% | \$0 - \$1,500 |
| 2 | \$30,000 - \$90,000 | 6% | \$1,800 - \$5,400 |
| 3 | \$90,000 - \$150,000 | 7% | \$6,300 - \$10,500 |
| 4 | \$150,000 - \$210,000 | 8% | \$12,000 - \$16,800 |
| 5 | \$210,000 - \$300,000 | 9% | \$18,900 - \$27,000 |
| 6 | \$300,000 + | 10% | \$30,000 + |
