

## US EXPORT CONTROLS ON UBIQUITI PRODUCTS

Ubiquiti products are subject to U.S. export controls. By selling, using or otherwise transferring Ubiquiti's products you are agreeing to comply with all applicable export and reexport control laws and regulations, including the Export Administration Regulations ("EAR") maintained by the U.S. Department of Commerce and trade and economic sanctions maintained by the Treasury Department's Office of Foreign Assets Control ("OFAC"). Specifically, no person or entity may—directly or indirectly—sell, export, reexport, transfer, divert, or otherwise dispose of any Ubiquiti product, software, or technology (including products derived from or based on such technology) to any destination, entity, or person prohibited by the laws or regulations of the United States, without obtaining prior authorization from the U.S. government as required by those laws and regulations.

No Ubiquiti products can be transferred without a license to any country subject to U.S. embargoes or anti-terrorism controls, currently Cuba, Iran, North Korea, Sudan, and Syria and the Crimea Region of the Ukraine. Additionally, many of Ubiquiti's encryption items are ENC-Restricted items and cannot be transferred without a license to government end-users in many countries. No person or entity may transfer Ubiquiti products without a license to anyone on a U.S. Government list of prohibited persons, including but not limited to U.S. Treasury Department's lists of Specially Designated, the U.S. Commerce Department's Denied Persons List, Entity List, or Unverified List: <https://www.bis.doc.gov/index.php/policy-guidance/lists-of-parties-of-concern> and <http://www.treasury.gov/resource-center/sanctions/SDN-List/Pages/default.aspx>). Further, Ubiquiti products may not be used for any chemical or biological weapons, and sensitive nuclear end-uses, or missiles to deliver them.

Additionally, please keep in mind that a number of Ubiquiti products, including our Embedded Products, cannot be exported without a license from the Bureau of Industry and Security to government end-users outside of the United States, Canada, Europe, Japan, and Australia. These products include the items identified as "ENC-Restricted" on the chart on **page 2** of this document.

You are responsible for ensuring that any of your employees, contractors, affiliates and customers are clearly made aware of these regulations. Ubiquiti is committed to conducting business with honesty and integrity, and in full compliance with the U.S. export control and trade and economic sanctions regulations. Classifications may change. Please check this form regularly to ensure continued compliance.

Failure to comply with U.S. export control and trade and economic sanctions laws and regulations can result in criminal sanctions, civil fines, debarment from government contracting, the loss of U.S. export privileges, and imprisonment. The reach of these laws and regulations covers U.S. persons as well as foreign persons, wherever located.

## Terms Used in Product Chart

**Product Family:** A logical grouping of products. Unless otherwise specified, a product family includes all versions for that family.

**ECCN:** Export Control Classification Number assigned by the U.S. Department of Commerce, Bureau of Industry and Security ("BIS") in the Commerce Control List ("CCL"). The ECCN determines the level of control of the item. Ubiquiti products could fall under one of many different ECCNs, including but not limited to:

5A002 - Information Security – Hardware (data confidentiality encryption greater than 64-bits in key space)

5A992 – Mass Market Hardware (see below)

**ENC-Restricted:** The U.S. government regulations for License Exception ENC differentiate between "Restricted" and "Unrestricted" hardware. An "ENC-Restricted" item cannot be exported to government end users in many countries. Please consult Section 740.17(b)(2) of the EAR.

**ENC-Unrestricted:** An "ENC-Unrestricted" item can be exported to government and non-government end-users that are: (1) not listed on any prohibited government list; and (2) not in a sanctioned/embargoed country.

**Mass Market:** The U.S. government regulations allow mass market encryption products containing strong encryption to be exported without a license to all countries other than those subject to anti-terrorism controls or U.S. embargoes, currently Cuba, Iran, North Korea, Sudan, and Syria and the Crimea Region of the Ukraine under ECCN 5D992. "Mass Market" indicates that the hardware has been classified as mass market hardware.

**CCATS:** Commodity Classification Automated Tracking System. This is the number assigned by BIS to products that it has classified on the Commerce Control List ("CCL").

**Government End-User:** Any foreign central, regional or local government department, agency, or other entity performing governmental functions; including governmental research institutions, governmental corporations or business units, and international governmental organizations. It does not include: utilities (including telecommunications companies and Internet service providers); banks and financial institutions; transportation; broadcast or entertainment; educational organizations; civil health and medical organizations; retail or wholesale firms; and manufacturing or industrial entities.
